Mr. Mathieson is the controlling shareholder and President of Fairview Capital. Mr. Clark is the Managing Partner and a portfolio manager of Darlington. The Filers are filing this Schedule 13G jointly but not as members of a group, and each disclaims membership in a group. Each of FCIM LLC, Fairview Capital, Mr. Mathieson and Mr. Clark disclaims beneficial ownership of the Stock, except to the extent of that person's pecuniary interest therein.
